1. Inform your HR to submit the application for you via WDA website <https://www.skillsconnect.gov.sg/web/guest/home> at least 1 day before Course Commencement date. (Note: WDA will reply within 3 working days regarding status of application.)
2. Fill up the enrolment form at SAA-GE and indicate choice of classes and submit to us. (Do not make payment at this point.)
3. Once we have received the enrolment form, we will then send out the Tax Invoice, Confirmation Letter and Terms & Conditions to your Company
4. Come down personally to SAA-GE to make payment using Company's cheque and complete the enrolment formalities.
